

**Assessment Required for Licensure as a Principal or Superintendent in Missouri**

Any individual seeking licensure as a principal or superintendent in the State of Missouri must successfully pass the licensure assessment administered by the Educational Testing Service. To assist those candidates seeking licensure, **MASSP, MAESP, MASA and MCSA OUTREACH** have collaboratively developed pre-assessment practice sessions to prepare individuals for the actual test. These practice sessions are held just prior to the administration of the assessment instrument.

Dates of the actual test and dates for each practice session are noted on this registration form.

**Dave Backer**, retired MASSSP Conference Director and **Larche Farrill**, William Woods University adjunct professor, are the facilitators for these sessions. They have scored the SLLA test numerous times for ETS, are very knowledgeable of the ISLLC standards and have combined the two to help develop these test preparation sessions.
